### 3. Pension Fund Conference in Istanbul

The conference organized by the Capital Markets Professionals Association Turkey (SPP) took place last Thursday 3rd of March in Istanbul. The conference was introduced by Mr. Murat Cetinkaya, Chairman of the Capital Markets Professionals Association Turkey (SPP).

In his speech, the EFFAS Chairman Dr. Jesús López Zaballos presented the European Federation of Financial Analysts Societies, counting actually with 26 national member societies, and its worldwide recognized Designations: EFFAS Certified European Financial Analyst Diploma (CEFA), EFFAS Risk Management Diploma, EFFAS Certified Environmental Social and Governance Analysts Diploma (ESG) and ACIIA Certified International Investment Analyst (CIIA).

Ms. Kyrali, analysed the Pension Fund System in various countries worldwide such as USA, Australia, UK, Germany, Hungary and the Scandinavian markets and its implications.

Professor Dr. Emrah Sener, took then the floor to analyse the Pension Fund alternative systems for the Turkish market. With a population over 80 million inhabitants, the people within the 15-64 age group constitute 67.4 percent of the total population; the 0–14 age group corresponds to 25.3 percent; while senior citizens aged 65 years or older make up 7.3 percent, the Turkish labour market is now developing its pension fund structure.
