Prof. Dr. Alexander Bassen

Academic Director of the Certified ESG Analyst® Programme

Alexander Bassen is a full professor of capital markets and management at the University of Hamburg, Faculty of Business, Economics and Social Science (Germany). He teaches courses in finance and investment, ESG and capital markets and reporting. Alex is a member of the German Advisory Council on Global Change of the German Federal Government. In addition, he served as a member of the EFRAG Project Task Force EU Sustainability Reporting Standard (PTF ESRS), the German Council for Sustainable Development — Advisory Body of the German Federal Government, and the G7 Impact Task Force. He is an Honorary Research Associate at the University of Oxford (Smith School of Enterprise and the Environment) and a Visiting Professor at the Hong Kong Baptist University. In addition, he is a member on several advisory committees for sustainable finance.

Alexander is since 2024 the inaugural Chair of the Independent Standards Board (ISB) of the Greenhouse Gas Protocol (GHG).



Sonia Artuso, CEFA, CIIA, CESGA

Sonia is the ESG Investment Integration Manager at Generali. She contributes to sustainable investment innovation as the Group Head of Sustainability and Social Responsibility (GS&SR) pivot for the Group CIO and A&WM area. She has a bachelor's degree from Università di Torino, majoring in Economics and Business, and holds the CIIA, CESGA and CEFA.

She collaborates with standard setters and contributes to several influential sustainability committees and task forces, including the FinDatEx ESG Technical Working Group, the Insurance Europe Sustainability Working Group and the AIAF Education Commission for ESG Issues. Sonia's commitment to sustainability also extends to academia, where she shares her knowledge as a lecturer at Cattolica University in Milan.

Among her latest publications are: Exploring the Effectiveness of Sustainability Measurement: Which ESG Metrics Will Survive COVID 19? published in the Journal of Business Ethics (Springer); How to improve Biodiversity information published in Extinction Governance edited by Atkins J. and Macpherson M. (Routledge) and Introduction to SRI: From Traditional to Sustainable Investing (McGraw-Hill).



Aurélie de Barochez is the Director of Consultancy at Moonshot, where she oversees assignments on ESG topics such as climate and biodiversity strategies, structuring ESG funds, defining impact strategies, and auditing ESG investment policies. Moonshot's clients include institutional investors, management companies, and ESG fund distributors.

Previously, Aurélie was Head of ESG Integration at Groupama Asset Management (2018–2023), where she introduced an ESG strategy to integrate ESG factors into investment decisions and developed an ESG training program for portfolio managers. She joined Groupama AM in 2015 as a financial and ESG analyst, specializing in the energy sector and environmental issues.

From 2012 to 2015, she worked at Novethic, certifying SRI funds, developing sustainable investment training, and conducting statistical studies. Aurélie began her career in 2011 as an SRI analyst at General and then at Agicam.

She holds a master's in Management from Audencia Nantes, a master's in International Law from Université Paris 2 Panthéon-Assas, and earned her SFAF (CIIA) certification in 2017. She is a member of the SFAF Commission for Extra-Financial Analysis.







Corinne Baudoin, CEFA

Corinne Baudoin has been a member of the SFAF board in charge of ESG topics since 2017 and she also participates in the SFAF Commission in charge of extra-financial analysis. She began her career as an equity fund manager at CCR Actions from 1997 to 2002. Then she participated in the creation of the "value investing" asset management company Metropole gestion in 2002, where she stayed until 2014. As an equity fund manager, she worked on the development of an ESG criteria integration tool into financial analysis and fund management. She is now a financial and ESG reporting consultant and teaches ESG analysis and reporting at the Dauphine University and PPA Business School in Paris.

Corinne has been an accredited Certified European Financial Analyst (CEFA) since 2000. She is also an agricultural engineer (ENSFA) and has a master's degree (DESS) in land-use planning and local authorities and a master's degree in Environmental law.



Dr Calace is Senior Vice President of Innovation and Accounts at Datamaran. He contributes to global innovation projects for the firm and heads the business development and account strategy. He speaks frequently at expert-conferences worldwide and has been invited as guest lecturer to top business schools, including the London Business School.

In 2019 he participated in the European Commission DG FISMA expert session on materiality. He is a member of the EFRAG Task Force on reporting of non-financial risks and opportunities and linkage to the business model and from 2021 a member of the EFRAG Working Group reviewing the EU Sustainability Reporting Standards. Anthony Cheung is Managing Director of ESG for PAG's Polymer Capital Management and is primarily responsible for driving sustainable investment and ESG integration within the group. Anthony was the first person in Asia to attain the Certified ESG Analyst® designation.
